

Basis of the Charge (set forth a clear and concise statement of the facts constituting the alleged unfair labor practices) On October 8, 2018, and within six months of the filing of this charge, Employer, American Federation of Labor and Congress of Industrial Organizations, by and through its supervisors and agents, (a) unilaterally changed wages, hours and terms and conditions of the bargaining unit without reaching a good faith impasse in negotiations with the recognized exclusive representative, OPEIU Local 2; (b) imposed terms seeking unlimited managerial discretion over workforce numbers, hours and days of operations; and (c) unilaterally reduced wages of bargaining unit employees. Charging Party OPEIU Local 2 requests that the Regional Director seek a temporary injunction pursuant to Section 10(j) of the Act to enjoin such Employer unfair labor practices pending final decision by the National Labor Relations Board.
